There had been one or two incidents of waste left on pavements. SS mentioned the dog waste composter he had at his home, which worked very well.

#### 2022/33 VILLAGE IMAGE

- i) Roxby grass cutting
  - The grass was looking dry due to the hot weather.
  - RL gave his invoice to the clerk for payment for cutting the PROWs. She would speak to Andy Tate about the request for public liability insurance.
  - PF reported the planters and tubs were looking good except the planter at the bottom of the village, which was always in shade.
  - The clerk would take pictures of the planters to attach to the monitoring report to send to the Community Grants Team.
- ii) Dragonby
  - The hedge from the garden next to the footpath was overgrown and encroaching onto the footpath. The clerk would write to the homeowner to ask if he would cut it back.

#### 2022/34 PLAYING FIELD

The clerk had sent the playground report to councillors. It made several recommendations: remove the old swing because the frame was rusty; take out the slide because it needed painting; remove the basketball post because it needed replacing. Action: RL would remove the seats to stop children using the swings; MV offered to paint the slide.

Councillors referred back to the 3 quotes received from North Lincs Council and the possibility of having to contribute 10% towards buying the new equipment. They needed to determine what equipment was actually needed for the playground. The clerk would write to Julie Reed and ask for some online brochures to help councillors choose more suitable equipment.

#### 2022/35 PLANNING APPLICATIONS

PA/2022/956: Planning permission to construct an agricultural irrigation reservoir on land north of Risby Road, Appleby: It is considered that the proposal will not have significant effects on the environment

PA/2022/758: Planning application to vary condition 1 of PA/2021/1960 to allow for external material changes: The Old Hall, 36 North Street, Roxby, DN15 0BL. The clerk would be submitting comments before the deadline. CHANGES REFUSED

#### 2022/36 ROADS

- i) The corner of South Street and Brackenholmes Lane was becoming increasingly dangerous. The road was sinking probably due to the natural springs that randomly appeared in that area. Cllr J Lee drove into the village that way to monitor the poor road conditions. She would report it again.
- ii) The verges on North Street were high and needed cutting as the view was being obstructed.
- iii) Cllr J Lee had reported the fly-tipping on Warren Road and it had been removed. She was working on getting a camera installed in that area. It seemed the culprit was a builder who dumped his rubbish on a regular basis.
- iv) Rubbish had also been dumped at the s-bend on Brackenholmes Lane.

The clerk had contacted the Roxby Village site administrator to ask for help but hadn't heard back. The website was working well. There was now a message facility on it but only companies looking for business had used it.

NLGEP - a meeting had been arranged for 1 August. SS would report back. He would be attending a NATS meeting in the coming week.

CW asked if there was any progress with buying the building. There seemed to be a lot of delays. It had been 4 years since the money had been allocated. There was nothing new to report

# iii) Ward Councillors

- A new Online directory called "LiveWell North Lincolnshire" was the go-to online directory for anyone looking to find information about a range of support and activity available locally to improve general health and wellbeing. The new website listed everything from organisations, support groups, community groups events and activities from across the county.
  - LiveWell catered for a wide range of needs with everything from reminiscence sessions, to street sport, music therapy and yoga classes, including social groups, coffee mornings, group walks and concerts.
- Levelling up; organisations were invited to apply for a share of £5.5m to kickstart projects.
   Examples of projects eligible for funding included further enhancing of
  - Town centres and high streets
  - Arts cultural heritage and creative activities
  - local sports facilities, leagues and tournaments
  - community measures to reduce cost of living.
- Free swimming sessions were back for the summer holidays in North Lincolnshire. From Monday 25 July until Sunday 4 September. Summer Daze sessions would be free for all under 16s at all NL Active swimming pools - the Pods, Ancholme Leisure Centre, Baysgarth Community Hub, Riddings Community Hub and Epworth Swimming Pool.
- In the past four weeks the council had awarded £60 worth of food vouchers to 3200 pensioners eligible for pension credit and council tax relief, and a further £70 to 1213 pensioners who also accessed council tax benefit.

#### 2022/41 ATTRACTING NEW PARISH COUNCILLORS

Need to attract at least 2 or 3 new councillors. PF suggested doing a leaflet drop in the village and putting it on the new Facebook page and website. The clerk would produce an A5 flyer which she would circulate to councillors for approval before asking Scunthorpe Instant Print to print 200. They would be distributed along with the Out and About magazine.
